# 4. FIRST AID MEASURES

Ingestion

: Wash out mouth with water. Move exposed person to fresh air. Keep person warm and at rest. # 6. ACCIDENTAL RELEASE MEASURES

#### Methods for cleaning up

Small spill

: Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see section 13). **Handling**
